#### **Technical expertise: RAAC**

As a professional institution and a learned society, we pride ourselves on our technical expertise applied for public benefit. With reinforced autoclaved aerated concrete (RAAC) grabbing headlines in every UK news outlet in late August and September this year, our expertise came to the fore.

CROSS and the Institution's RAAC Study Group have been central to dealing with the RAAC matter. A detailed update, including information about our guidance, was provided in the October issue of *The Structural Engineer*.

# Implementation of Building Safety Act

The Institution has been active in preparing the UK engineering and wider built environment industry for the implementation of the Building Safety Act, the most important piece of construction legislation in this country in the past 30 years.

Our web portal (www.istructe.org/resources/building-safety-act/) provides wide-ranging advice covering the scope and impact of the Act and the legal implications. Following the recent publication of secondary legislation, we are currently drafting further detailed guidance on safety cases, the golden thread and gateways.

# Appointment as Voluntary Reporting Service provider

CROSS has been appointed by the Building

Safety Regulator as Voluntary Reporting Service (VRS) provider in England and Wales. Vital to the work of CROSS are submissions to its confidential reporting system – a way for professionals to anonymously share safety concerns and insights. The CROSS VRS accepts safety reports on structure- and fire-related issues and provides advisory notes to industry. All are made freely available on the CROSS website (www.cross-safety.org/uk) to help make structures safer.

#### **Sustainability focus**

Staying true to our mission of public safety, we continue to focus rightly on creating a world that uses resources appropriately and addresses environmental and societal challenges.

The Circular economy guide was published in July of this year, building on the Institution's growing library of sustainability guidance and providing a framework for the reuse of buildings and building elements. The Institution

also issued its first sustainability position paper, on the use of ground granulated blast-furnace slag (GGBS). This was developed with industry and takes a global perspective on sustainable material sourcing.

The Institution continues to provide both technical and governance support to the Net Zero Carbon Building Standard. This will provide a science-based approach for buildings to meet net-zero criteria, helping meet industry sustainability objectives.

We also launched new IPD regulations this year. Together with changes to our examinations, these will put more emphasis on sustainability within the Professional Review process.

## Regional groups and membership support

It has been a privilege to visit some of our regional groups for the first time and it was wonderful to connect with many of our members. For me, each interaction has emphasised the enthusiasm of our regional group volunteers and I have felt energised for the future

We have also opened our first non-UK office in the Hong Kong SAR this November. This will enable us to better support our members based in the region and to build links with local employers and universities. It will also allow us to collaborate when appropriate with the Hong Kong Institution of Engineers (HKIE) in support of the structural engineering profession.

We have launched a new route to the Associate (AlStructE) grade, which now offers an opportunity for eligible Graduates to have

their professional competence recognised when they pass the PRI assessment. Further details about these changes can be found on **page 12**.
